PROPOSED PROCEDURAL SCHEDULE

TO THE HONORABLE RACHELLE NICOLETTE ROBLES, ADMINISTRATIVE LAW JUDGE:

COMES NOW, Oncor Electric Delivery Company LLC (“Oncor”) pursuant to SOAH Order No. 1 and, on behalf of itself, the Commission Staff of the Public Utility Commission of Texas, the Steering Committee of Cities Served by Oncor, and Texas Energy Association for Marketers (collectively, “Parties”), files the following proposed procedural schedule to be adopted for this proceeding and help facilitate a final Order to be effective on March 1, 2023 consistent with 16 Tex. Admin. Code (“TAC”) § 25.182(d)(9)(B):

Except as specifically noted in the above-referenced schedule, the Parties recommend the following regarding discovery, objections and motions to compel:

- responses to requests for information (RFIs) shall be filed within eleven (11) calendar days of receipt of the RFIs;
- objections to RFIs shall be filed within five (5) calendar days of receipt of the RFIs;
- motions to compel shall be filed within two (2) calendar days of receipt of objections;
- responses to motions to compel shall be filed within two (2) calendar days of receipt of a motion to compel; and
- drafts of testimony and any emails transmitting them are not discoverable.

II. Conclusion & Prayer

WHEREFORE, the Parties respectfully request that the above-referenced proposed schedule be adopted.
