

The facts as related in this affidavit are true and correct within Affiant's personal knowledge.

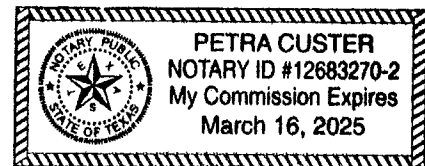
