**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On June 6, 2022, SP Utility Company, Inc. (SP Utility) filed an application for a Class D rate adjustment for Certificate of Convenience and Necessity (CCN) Nos. 12978 and 20817.

On July 8, 2022, the administrative law judge (ALJ) filed Order No. 2, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and notice and recommendation on final disposition including a proposed tariff sheet reflecting the requested rate change by July 14, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

In accordance with 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is awaiting SP Utility's filing of the supplemental information needed to cure its deficiencies in Docket No. 53687 due to the ALJ's intent to consolidate Docket Nos. 53686 and 53687. Accordingly, Staff respectfully requests that its deadline to file comments on the administrative completeness of the application and notice and recommendation on final disposition including a proposed tariff sheet reflecting the requested rate change be extended to August 4, 2022.
