# ORDER NO. 3 FINDING PETITION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE AND NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the June 8, 2022 petition of AM Real Estate Solutions, Inc., Trustee of the AM Business trust 2021-001, to amend the City of Grand Prairie's certificate of convenience and necessity (CCN) in Ellis County by streamlined expedited release. On August 4, 2022, AM Real Estate filed supplemental information.

#### I. Finding Petition, as Supplemented, Administratively Complete

On September 8, 2022, Commission Staff recommended that the petition, as supplemented, be found administratively complete. The administrative law judge (ALJ) finds the petition, as supplemented, administratively complete. The finding of administrative completeness does not address the merits of the petition.

## **II.** Finding Notice Sufficient

The petition includes a signed certificate of service in which petitioner certified that it mailed a true and correct copy of its petition to the CCN holder, by certified mail on the date the petition was filed with the Commission. Petitioner also included an affidavit attesting to this provision of notice to CCN holder. The ALJ finds the notice sufficient.

## III. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the

requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
