ORDER NO. 6
FINDING NOTICE SUFFICIENT AND ADOPTING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice provided by CSWR-Texas Utility Operating Company, LLC. On November 1, 2022, CSWR-Texas filed the affidavit of Aaron Silas, director of regulatory operations for CSWR-Texas, attesting that notice of the application at issue in this proceeding was mailed to all current customers, neighboring utilities, and affected parties on October 28, 2022.

On November 14, 2022, Commission Staff filed a recommendation on the sufficiency of the notice.

The administrative law judge finds the notice sufficient and adopts the following procedural schedule:

Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the certificate of convenience and necessity amendment	December 29, 2022
Deadline for parties to file a response to Commission Staff's recommendation on approval of the sale	January 12, 2023
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed	January 26, 2023

¹ Under 16 Texas Administrative Code (TAC) § 24.239(b), the intervention period must not be less than 30 days unless good cause is shown. 30 days after October 28, 2022, is Sunday, November 27, 2022. Under 16 TAC § 22.4(a), the deadline moves to Monday, November 28, 2022, the next day the Commission is open for business.
