COMMISSION STAFF'S SECOND REQUEST FOR EXTENSION

I. INTRODUCTION

On June 13, 2022, CSWR-Utility Operating Company, LLC (CSWR-Texas) and George Fuller (Mr. Fuller), executor of the estate of Virginia Fuller, (collectively, Applicants), filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Lubbock County. Specifically, CSWR-Texas, CCN No. 21120, seeks approval to acquire facilities and to transfer all of the sewer service area from Mr. Fuller under inactive sewer CCN No. 20743 to the J E Franklin Trust under sewer CCN No. 21120. CSWR-Texas filed supplemental information on June 14, 20, and 27, August 16, September 1, and December 2, 2022, and January 9, 2023.

On January 20, 2023, the administrative law judge (ALJ) filed Order No. 7, directing CSWR-Texas Utility Operating Company (CSWR-Texas), George Fuller, executor of the estate of Virginia Fuller (Mr. Fuller), and the Staff (Staff) of the Public Utility Commission of Texas (Commission), (collectively, the parties) to jointly clarify two issues raised in Order No. 7 by January 27, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to formulate a response to Order No. 7. Therefore, Staff respectfully requests that the parties' deadline to file a joint response to Order No. 7 be extended to February 28, 2023. Staff further respect that the additional deadlines in Order No. 7 be amended accordingly.

III. CONCLUSION

For the reasons stated above, Staff respectfully requests that the deadline for the parties to jointly file a response to Order No. 7 be extended until February 28, 2023.
