COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION

I. INTRODUCTION

On June 13, 2022, CSWR-Utility Operating Company, LLC (CSWR-Texas) and George Fuller (Mr. Fuller), executor of the estate of Virginia Fuller, (collectively, Applicants), filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Lubbock County. Specifically, CSWR-Texas, CCN No. 21120, seeks approval to acquire facilities and to transfer all of the sewer service area from Mr. Fuller under inactive sewer CCN No. 20743 to the J E Franklin Trust under sewer CCN No. 21120. CSWR-Texas filed supplemental information on June 14, 20, and 27, August 16, September 1, and December 2, 2022, and January 27 and June 16, 2023.

On April 25, 2023, the administrative law judge (ALJ) filed Order No. 11, directing the Staff (Staff) of the Public Utility Commission of Texas and the Applicants (collectively, the parties) to jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs by June 20, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review and finalize the joint proposed notice of approval. Therefore, Staff respectfully requests that the parties' deadline to file a joint proposed notice of approval be extended to June 27, 2023. Staff has conferred with the Applicants and is authorized to represent that they are unopposed to this extension request.

III. CONCLUSION

For the reasons stated above, Staff respectfully requests that the deadline for the parties to file a joint proposed notice of approval be extended until June 27, 2023.
