JOINT NOTICE OF PROPOSED CORRECTION TO NOTICE OF APPROVAL

COME NOW CSWR-Texas Utility Operating Company, LLC ("CSWR-Texas") and George Fuller, Executor of the Estate of Virginia Fuller ("Franklin Sewer") together with the Staff ("Staff") of the Public Utility Commission of Texas ("Commission") (collectively, "the Parties"), and file this Joint Notice of Proposed Correction to Notice of Approval. This notice of correction is timely under 16 Texas Administrative Code ("TAC") § 22.35(c)(1).

I. CORRECTION

When CSWR-Texas filed the Joint Supplemental Motion to Admit Evidence and Proposed Notice of Approval and associated tariffs on June 27, 2023 (Interchange Item No. 52), the top of the first page of the sewer tariff incorrectly stated "Docket No. 53721," instead of "Docket No. 53709." As a result, the sewer tariff attached to the Notice of Approval reflected the incorrect docket number, Docket No. 53721. The Parties respectfully request the Commission issue a corrected notice of approval with an attached sewer tariff that states Docket No. 53709 at the top of the tariff. No other corrections are necessary; the correct docket number was used elsewhere in the sewer tariff. Assuming that a corrected notice of approval is issued, Commission Staff will be able to file clean tariffs with the correct docket number, Docket No. 53709 on the first page of the sewer tariff.
