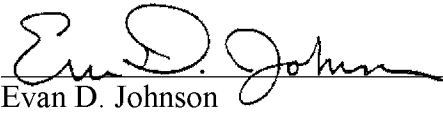

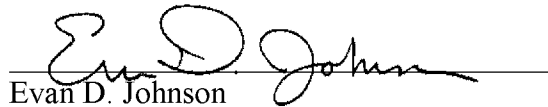

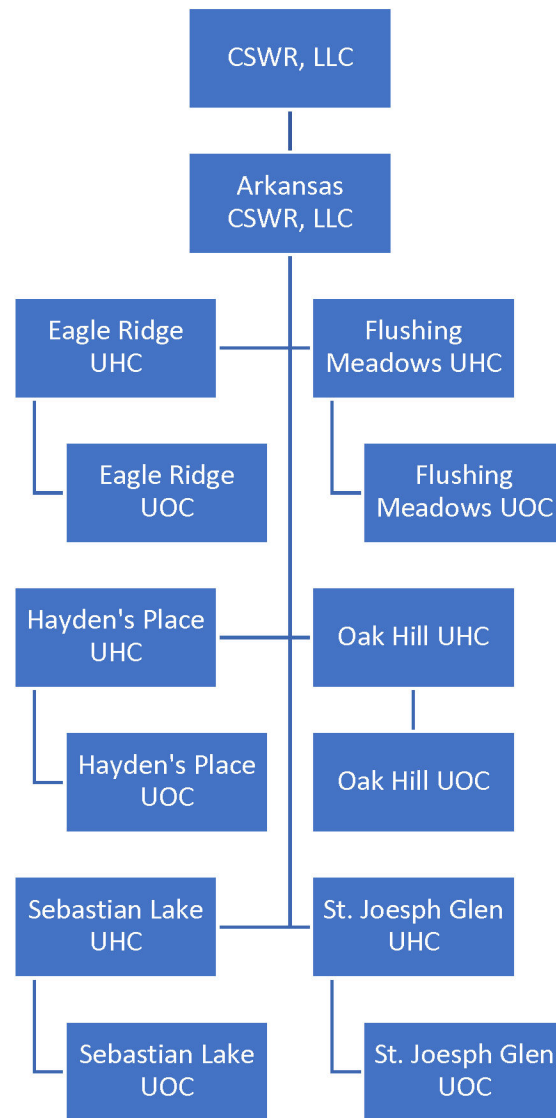

### Arkansas CSWR Organizational Chart Detail





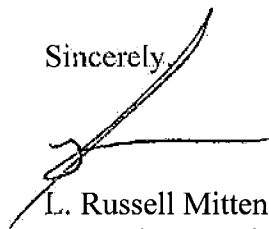

TO WHOM IT MAY CONCERN:

I am submitting this letter on behalf of Central States Water Resources, Inc. (sometimes referred to as "Company"), as General Counsel of both the Company and its affiliates. In that capacity, I am duly authorized to speak on the Company's behalf in this matter.

Central States Water Resources, Inc., is an affiliate of the applicant-buyer in this proceeding, CSWR-Texas Utility Operating Company, LLC ("CSWR Texas"). Under terms of each *Agreement for Sale of Utility System*, the Company has the express right to assign its interests in the agreement to an affiliated entity. Prior to or as part of the closing of an acquisition transaction, Central States Water Resources, Inc., will transfer all its interests in each such agreement to CSWR Texas, which will then serve as the owner and operator of the acquired system and the holder of all associated certificate number(s). Following the assignment, Central States Water Resources, Inc., will have no further interest in any acquired asset.
