Please also reconcile the \$9,242,416 figure shown at page 4, line 3 of the testimony of Meghan E. Griffiths with the \$9,239,731 figure reported on Schedule G-14.1 at line 18.
- Staff 8-2** Please refer to Exhibit RMD-8 to the testimony of Ryan M. Dumas and provide separately by year for each of the years 2017 through 2022 a list of each ESL project number that had charges to ETI in that year and the amount charged by project to ETI each year.
- Staff 8-3** Please provide the depreciation rate for amounts that were generally capitalized but cannot be tracked by specific FERC account. Please include the underlying factors that produce the depreciation rate and any related workpapers.
