APPLICATION OF ENTERGY TEXAS, INC. FOR AUTHORITY TO CHANGE RATES

ORDER SETTING PREHEARING CONFERENCE

This docket has attracted significant interest in Preliminary Order Issues 68 and 69 referred by the Public Utility Commission of Texas (Commission) relating to Entergy Texas, Inc.'s (ETI) proposed Transportation Electrification and Charging Infrastructure (TECI) Rider and the Transportation Electrification and Charging Demand Adjustment (TECDA) Rider. In addition to all previously filed motions to intervene (which have been ruled upon), there are two pending late-filed motions filed by Americans for Affordable Clean Energy (AACEA) on October 11, 2022, and by El Paso Electric Company (EPE) on October 17, 2022. Relevant to EPE's late filed motion, the administrative law judges previously denied Southwestern Public Service Company's (SPS) Motion to Intervene in SOAH Order No. 4, issued on September 6, 2022. SPS appealed the denial to the

Commission on September 16, 2022. Although the ALJs did not receive notice that

the Commission intended to take up SPS's appeal and the Commission has not

issued an order on the matter, EPE indicates that the Commission voted to

overturn the ALJs' denial of SPS' intervention at the Commission's Open Meeting

on October 6, 2022. Accordingly, a prehearing conference will be held at 10:00

AM (CT) on October 25, 2022, remotely via Zoom videoconference. The audio

portion of the hearing will be recorded, and it will be the official record of the

proceeding unless a court reporter is retained and provides a written transcript.
