ENTERGY TEXAS, INC.’S RESPONSE TO SOAH ORDER NO. 8

Entergy Texas, Inc. (“ETI” or the “Company”) files this response to SOAH Order No. 8. ETI has conferred with the parties and is authorized to state that all parties (other than Americans for Affordable Clean Energy, Southwestern Public Service Company, and El Paso Electric Company from which ETI had not heard at the time of this filing) support a deadline of November 23, 2022 for any party to request a prehearing conference and the parties are available for a prehearing conference, if requested, on the following dates and times:

November 28, 2022, between 9 a.m. and 5 p.m.;¹

November 29, 2022, between 9 a.m. and 5 p.m.;

December 1, 2022, between 9 a.m. and 5 p.m.

Sierra Club has expressed a preference that any prehearing conference begin no earlier than 10:00 a.m. Central Time. ChargePoint expressed a preference that any prehearing conference be held on December 1, 2022.

¹ November 28, 2022 was added shortly before the filing as one alternative date on which to hold the prehearing conference. At the timing of this filing, only Staff, ETI, TIEC, and OPUC had indicated availability for this date.
