**JOINT PROPOSED WITNESS ORDER AND WAIVERS OF**  
**CROSS-EXAMINATION OF WITNESSES**

COMES NOW, Entergy Texas, Inc. (“ETI”) and submits, on behalf of itself, Public Utility Commission of Texas Staff (“Staff”); Cities<sup>1</sup>; FlashParking, Inc.; the Office of Public Utility Counsel (“OPUC”); Southwestern Public Service Company (“SPS”); Sierra Club; Texas Industrial Energy Consumers (“TIEC”); the Kroger Co. (“Kroger”); the United States Department of Energy (“DOE”); Walmart Inc. (“Walmart”); ChargePoint, Inc. (“ChargePoint”); Sempra Infrastructure Partners (“SI”); Americans for Affordable Clean Energy (“AACE”); and El Paso Electric Company (“EPE”), all parties to the above-referenced proceeding (collectively, the “Parties”), this joint proposed witness order and list of witnesses for whom cross-examination has been waived.

In accordance with SOAH Order No. 10, the Parties have conferred to prepare a list of witnesses the parties intend to call to testify during the Hearing on the Merits, commencing December 5, 2022; listed in the order that the party intends to call them, as well as a list of witnesses for whom cross-examination has been waived. Witnesses that were previously addressed in SOAH Order No. 11 are excluded.

SOAH Order No. 10 requires the Parties to submit the Parties’ joint list of witnesses that each party intends to call to testify and a joint list of those witnesses for whom cross-examination has been waived by December 2, 2022. Accordingly, this pleading is timely filed.


