Pursuant to SOAH Order Nos. 11 and 12, Entergy Texas, Inc. ("ETI") files this joint proposed procedural schedule regarding rate case expenses on behalf of itself, Cities, and the Staff ("Staff") of the Public Utility Commission of Texas ("Commission") (collectively, the "Parties").
