Kroger is a corporation engaged in the business of selling groceries at retail throughout 2. the United States.

3. On July 1, 2022, Entergy Texas, Inc. ("Entergy" or "Company") filed an Application for

Authority to Change Rates.

4. Kroger is one of the largest retail food companies in the United States, Kroger operates

numerous grocery stores and other facilities in the state of Texas. These stores purchase millions

of kWh of electricity from the Company annually. The grocery stores operated by Kroger are

high load factor facilities that use energy for food storage, lighting, heating, cooling and

distribution, often on a 24 hour a day, 7 day a week basis. If the Company's application is

granted, then the cost for electric power service to Kroger could be substantially impacted.

Accordingly, Kroger has a substantial and vital interest in the outcome of this proceeding which

cannot be adequately represented by any other party. Kroger intends to present evidence related

to revenue requirements, rate design and revenue allocation.

5. Kroger believes that its intervention will not prejudice any of the parties to this matter.
