AGREED MOTION TO CANCEL RATE CASE EXPENSE HEARING

Entergy Texas, Inc. ("ETI") files this agreed motion to cancel the hearing on rate case expenses currently scheduled for March 1, 2023. The parties, other than those addressing only Preliminary Order Issues Nos. 68 and 69, have reached a settlement in principle regarding ETI's recovery of rate case expenses. The parties plan to incorporate this settlement in principle regarding rate case expenses into the broader settlement they are working to finalize that will resolve all issues in this proceeding other than those related to Preliminary Order Issues Nos. 68 and 69. Accordingly, no hearing on rate case expenses is necessary and the parties request that the March 1, 2023 hearing be canceled. ETI is authorized to represent that all applicable parties (ETI, Commission Staff, Office of Public Utility Counsel, Cities, Texas Industrial Energy Consumers, Walmart, Inc., Federal Executive Agencies, Sempra Infrastructure Partners, LP, Sierra Club, and Kroger, Inc.) support this motion.
