**ENTERGY TEXAS, INC.'S STATUS REPORT**


Pursuant to State Office of Administrative Hearings (“SOAH”) Order No. 12, Entergy Texas, Inc. (“ETT”) files this status report. The parties have made significant progress toward filing a final settlement and associated documents in this proceeding. However, additional time is needed to complete these tasks.

Pursuant to SOAH Order No. 19, ETI has conferred with the parties. At this time, ETI does not believe an extension of the jurisdictional deadline is necessary. Further, ETI believes, given the progress made by the parties, that an abatement is not warranted and could result in unnecessary delay. However, ETI is mindful of the approaching jurisdictional deadline and will closely monitor the parties’ progress and propose appropriate action as needed to allow for an orderly conclusion to this proceeding.

ETI will file another status report in 30 days if final settlement documents have not been filed by that time.


