COMMISSION STAFF’S REQUEST FOR EXTENSION

I. INTRODUCTION

On June 15, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Patterson Water Supply, LLC (Patterson Water) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Dallas, Denton, Parker, Tarrant, and Wise counties. Applicants filed supplemental information on June 15 and 20, July 29, August 11, 15, and 16, and September 6, 2022.

On January 10, 2023, the administrative law judge (ALJ) filed Order No. 8, requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide the clarifications and information required by Order No. 6 by January 27, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Due to the unique nature of the issues presented for clarification in Order No. 6 and its potential effect on other similar dockets, Staff needs more time to evaluate and discuss the issues internally in order to develop a more universal response that may apply to several dockets. Therefore, Staff respectfully requests an extension of time until February 10, 2023, for Staff provide clarification and information in response to Order No. 6.

III. CONCLUSION

Staff respectfully requests an order consistent with the foregoing request.
