COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF CLOSING DOCUMENTS

I. INTRODUCTION

On June 15, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Patterson Water Supply, LLC (Patterson Water) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Dallas, Denton, Parker, Tarrant, and Wise counties. The Applicants filed supplemental information on June 20, July 29, August 11, August 15, August 16, and September 6, 2022.

On March 2, 2023, the administrative law judge (ALJ) filed Order No. 12, which required the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation regarding the sufficiency of Applicants' closing documents by April 7, 2023. Therefore, this pleading is timely filed.

II. SUFFICENCY OF CLOSING DOCUMENTS

Staff has reviewed the closing documents filed by Applicants on March 24, 2023 and recommends that they are sufficient. Based on its review, Staff has determined that the Applicants' filing meets the requirements of 16 Texas Administrative Code (TAC) § 24.239(a), which requires the filing of a sale, transfer, or merger (STM) application and the provision of public notice at least 120 days before the effective date of a proposed transaction. Under 16 TAC § 24.239(i), the proposed transaction may be completed at the end of the 120-day period of at any time after the transferee receives notice that a hearing will not be required.

Applicants filed notice of the completed transaction on March 24, 2023, which included a bill of sale signed by both the transferor and the transferee and assigning Patterson Water's water

system to CSWR-Texas Water. The effective date of the transaction is listed on the bill of sale as March 23, 2023, and the bill of sale was signed by the transferor and transferee on March 23, 2023. Notice was completed on September 30, 2022, which is more than 120 days before the bill of sale was signed on March 23, 2023. Therefore, Staff recommends a finding that Applicants' closing documents are sufficient and satisfy 16 TAC § 24.239(a), (i), and (*l*).

With regard to customer deposits, the original application states that there are no customers with deposits held by the transferee in the transferred service area. Further, in the Applicant's closing documentation, the Applicants state that there are no outstanding customer deposits associated with these water and sewer systems. Staff therefore recommends a finding that customer deposits have been adequately addressed as required by 16 TAC § 24.239(k) and (*I*).

III. PROCEDURAL SCHEDULE

In accordance with Staff's recommendation that the Applicants' closing documents be found sufficient, Staff proposes the following procedural schedule:

Deadline for applicants to file signed consent forms with the Commission	May 19, 2023
Deadline for parties to jointly file Proposed Notice of Approval, including findings of fact, conclusions of law, and ordering paragraphs	June 2, 2022

IV. CONCLUSION

For the reasons discussed above, Staff respectfully requests that an order be issued finding Applicants' closing documents sufficient and adopting the proposed procedural schedule.
