**JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE
REGARDING CAPITAL IMPROVEMENT PLAN AND REQUEST FOR EXTENSION**

CSWR-Texas Utility Operating Company, LLC (“CSWR Texas”), together with the Staff of the Public Utility Commission of Texas (“Commission Staff”) (collectively, “the Parties”) file this Joint Supplemental Motion to Admit Evidence Regarding Capital Improvement Plan and Request for Extension.

On January 3, 2024, the Administrative Law Judge issued Order No. 20 requesting that the parties file a supplemental motion to admit the capital improvement plan filed on November 7, 2023, and Staff’s recommendation on the capital improvement plan filed on November 20, 2023. Therefore, the Parties respectfully request that these two items be admitted as evidence into the record of this case.

Staff is currently finalizing CSWR-Texas’s tariffs to reflect the interim rates approved in Docket No. 54565. The tariffs previously filed in this docket for which consent forms were provided are incorrect. Therefore, the Parties respectfully request a two week extension until January 26, 2024, to file updated corrected tariffs in this docket prior to the Notice of Approval being issued.
