## **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On June 15, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Patterson Water Supply, LLC (Patterson Water) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Dallas, Denton, Parker, Tarrant, and Wise counties.

On January 16, 2024, the administrative law judge (ALJ) filed Order No. 21, requiring the parties to file updated corrected tariffs in this docket and move to admit the corrected tariffs into evidence by January 26, 2024. Therefore, this pleading is timely filed.

## I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff is currently finalizing CSWR-Texas' s tariffs to reflect the interim rates approved in Docket No. 54565. The tariffs previously filed in this docket for which consent forms were provided are incorrect. Staff requires additional time to finalize the tariffs. Therefore, the parties respectfully request an extension until February 2, 2024. Staff has conferred with the parties and is authorized to represent that they are not opposed to Staff's extension request.

#### **II. CONCLUSION**

Staff respectfully requests the entry of an order consistent with the above request for extension.
