Dear Mr. Dodson:

On June 15, 2022, the Public Utility Commission of Texas (Commission) received the request to change the name and update CCN records to reflect the conversion of Becker-Jiba Water Supply Corporation (WSC) to Becker-Jiba Special Utility District (SUD), under Texas Water Code (TWC), Chapter 13, and 30 Texas Administrative Code (TAC) §§293.11 and 293.12.

On June 19, 2019, the Texas Commission on Environmental Quality (TCEQ) approved the district creation and conversion of Becker-Jiba WSC to Becker-Jiba SUD under TWC Chapters 49 and 65; 30 TAC §293.11; and the procedural rules of the TCEQ. A successful confirmation election of the permanent Board of Directors for Becker-Jiba SUD was held on November 5, 2019. With this election, Becker-Jiba WSC is now Becker-Jiba SUD.

As part of the conversion process, Becker-Jiba SUD is required to file for dissolution of Becker-Jiba WSC. The Resolution No. 2019-005 including the Articles of Dissolution to dissolve Becker-Jiba WSC was approved by the Board of Directors on January 20, 2020. The dissolution of Becker-Jiba WSC allows for the transfer of the corporation's assets and liabilities to the SUD, therefore dissolving the corporation. I confirmed an "Certificate of Termination" was issued to Becker-Jiba WSC by the Office of Secretary of State on May 13, 2022.

Enclosed is a copy of the Certificate of Convenience and Necessity for water CCN No. 10820 reflecting the transfer and conversion from Becker-Jiba WSC to Becker-Jiba SUD in Project No. 53722. The Commission's records have been updated accordingly. No boundary change has been made to CCN No. 10820 in Project No. 53722.
