On this property Route 5 – Link- N-1 there are two inhabited houses and structures that would be DIRECTLY AFFECTED by the proposed alternative route option.

Please help these senior citizens by NOT approving this proposed alternative Route #5, Links: A-D-G-I-N-1-N-2-O-Q.


We also oppose to this other route links.
