JOINT APPLICANTS’ MOTION FOR RECONSIDERATION OF ORDER NO. 1

Joint Applicants AEP Texas Inc. and Sharyland Utilities, L.L.C. file this motion for reconsideration of Order No. 1 filed on June 30, 2022 (Item No. 8).

As provided in Joint Applicants’ Request for Referral to SOAH (Item No. 7), the above-referenced application is subject to the 180-day deadline set forth in PURA § 39.203(e). The Commission’s Order in Project No. 52682 mandating the construction of this transmission project was issued pursuant to PURA §§ 35.055(b) and 39.203(e).¹ PURA § 39.203(e) requires the Commission to issue a final order before the 181st day after the date the application is filed or the application is approved. Therefore, the 180-day statutory deadline applies to this proceeding as opposed to the one year deadline currently included in Order No. 1.

In addition, under 16 TAC §§ 22.52(a)(1)(A) and 22.104(b), the intervention deadline for an application filed under PURA § 39.203(e) is 30 days after the date the application was filed, or July 29, 2022, as opposed to 45 days after the application was filed.

For these reasons, Joint Applicants respectfully request that Order No. 1 be reconsidered to reflect the statutory deadline and intervention deadline applicable to this proceeding.
