**FILE-SHARING SITE INFORMATION AND REMINDER TO PARTIES REGARDING
PRE-HEARING SUBMISSIONS**

AEP Texas Inc. and Sharyland Utilities, L.L.C. (“Joint Applicants”) provide this File-Sharing Site Information and Reminder to Parties Regarding Pre-hearing Submissions, and would respectfully show as follows.

I. FILE-SHARING SITE

Consistent with SOAH Order No. 3 in this docket, the Joint Applicants will provide access to an “iManage” file-sharing site to be used for uploading exhibits in this docket. Each party to this case will receive an individual email directly from “iManage” so that they can register and use the file-sharing site to upload all hearing exhibits, including a copy of any prefiled testimony, by September 2, 2022. There will be a folder for each party on the file-sharing site into which the party should upload the party’s exhibits or exhibits.

II. REMINDER REGARDING PRE-HEARING SUBMISSIONS

As a reminder to all parties, SOAH Order No. 3 requires the following pre-hearing submissions to be completed by this Friday, September 2, 2022:

1. Parties shall confer and file a joint witness list identifying (a) all witnesses expected to testify during the hearing, and (b) all witnesses for whom the parties have waived cross-examination;
2. Each party shall upload all hearing exhibits and an exhibit list to a file-sharing site to be provided by Joint Applicants.

3. Each party shall deliver to the court reporter two copies of their marked exhibits, consisting of one physical copy (the record copy) and one electronic copy provided on a USB/flash drive (the court reporting copy), along with the party' s witness list and exhibit list. The parties should make arrangements directly with the court reporter on how and when the exhibits will be delivered to ensure that someone is available to accept delivery.
4. Each party shall deliver two physical copies of their marked exhibits (the appeals copies) to State Office of Administrative Hearings (SOAH) Docketing.
5. Joint Applicants shall provide the ALJs with access to the shared site containing the parties' exhibits.

Joint Applicants provide the following additional information regarding the five items above:

1. Joint Applicants have emailed the parties regarding the joint witness list and waiver of cross-examination.
2. The file sharing site information is provided above and will also be provided by email.
3. Joint Applicants will comply with Item 3 above and remind parties to do the same for their testimonies and any other exhibits.
4. Joint Applicants will comply with Item 4 above and remind parties to do the same for their testimonies and any other exhibits.
5. Joint Applicants will comply with Item 5 above.
