### II. TEXAS-NEW MEXICO POWER COMPANY'S INTEREST

TNMP is a transmission and distribution utility obligated to provide safe, reliable service within the ERCOT region and, as such, may be affected by the proposed facilities and connections being planned by Grid United Texas, LLC ("Grid United Texas") as outlined in its

application filed with the Public Utility Commission of Texas on July 5, 2022 (Application"). The Application proposes a project (the "Project") that would facilitate the import and export of power between the Electric Reliability Council of Texas ("ERCOT") and the Western Electricity Coordinating Council ("WECC") by interconnecting HVDC converter facilities at LCRA Transmission Services Corporation's Bakersfield Switching Station from an endpoint on El Paso Electric Company's system. Any Commission action concerning the import and export of electricity between ERCOT and the WECC will directly affect the flow of electricity on TNMP's electric facilities in West Texas and possibly reliability aspects of the ERCOT transmission grid.

Furthermore, TNMP owns, operates, and maintains transmission and distribution lines and stations in West Texas. The study area includes TNMP service territory such as Fort Stockton and Pecos. All or a portion of these facilities may be impacted by the Project.

TNMP has a justiciable interest in the outcome of this proceeding and, therefore, pursuant to 16 TAC §§ 22.103 - 104., TNMP requests intervenor status in this docket.

### III. CONCLUSION

Wherefore, premises considered, Texas-New Mexico Power Company respectfully requests that this motion to intervene be granted and for such other and further relief to which it may show itself to be entitled.
