**UNDINE REQUEST FOR CLARIFICATION**

Undine Texas, LLC (“Undine”) hereby requests clarification from the Administrative Law Judge (“ALJ”) regarding the status of this matter. Undine submitted this STM application on July 1, 2022 (Docket Id. No. 53765-1). On August 31, 2023, the parties submitted a Joint Motion and Proposed Order (Docket Id. No. 53765-424). On September 19, 2023, the ALJ issued Order No. 18 Requiring Clarification and Briefing. Undine filed its response to Order No. 18 on September 25 and Staff filed its response on October 17, 2023 (Docket Id. Nos. 427-428 and 429, respectively). Noting the Parties’ substantial desire to conclude this transaction (the STM application has been on file for over 16 months), Undine respectfully requests clarification from the ALJ on whether there is additional information the ALJ requires of the Applicant to proceed with a decision on the matter.
