We have already sent a Formal Complaint to the PUC under Docket No. 53811 concerning the turning off of our water by Nancy Nye at El Paso Water Utility. In researching the manufactured violations that she used to do this, our attorney received a list of violations going back to 2009 from Patricia Borschow, Legal Counsel for the Public Service Board.

All violations from 2012 to 2020 are missing. If this list is correct we would like to request an investigation of tampering with all of the violations, real and manufactured, that have come from Nancy Nye that were used to turn off our water. Enclosed is a copy of the list of violations. This could possibly affect all of the violations written going back 10 years and violations that never came from Rudy Pena and Manny, the inspectors who we reported to Sonia Wyatt in 2012 for notifying companies that they were monitoring the day before they went for more than 10 years.

The investigation by the TCEQ did nothing about this and if they were doing this with other companies there would be hundreds of bad reports. There was no interest in investigating this by Nancy Nye after we reported it to Sonia Wyatt. Instead Nancy Nye sent Rick Pedregon, an inspector to tell me she would close our business if I told anyone. This was 1 week after she had 4 different agencies monitoring inside and outside of the building for 2 months and they found no violations.

Enclosed is all the information concerning this.
