**COMMISSION STAFF’S SECOND REQUEST FOR EXTENSION**

**I. INTRODUCTION**

On July 11, 2022, John C. Gilliland (Mr. Gilliland), filed a formal complaint on behalf of Arizona Traders Company against El Paso Water Utilities Public Service Board alleging wrongful disconnection of water service. This complaint was filed under 16 Texas Administrative Code (TAC) § 22.242. Mr. Gilliland filed supplemental information on July 19, 2022, August 5, August 9, August 12, August 16, August 22, August 26, 2022, September 2, and September 29, 2022.

On October 18, 2022, the administrative law judge (ALJ) filed Order No. 5, ordering Arizona Traders to file a report on its efforts to exhaust its administrative remedies with the City of El Paso or the El Paso Water Utilities Public Service Board by October 25, 2022, and directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental statement of position by November 14, 2022. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Arizona Traders has not yet filed a response to Order No. 5. Therefore, Staff is unable to formulate a supplemental statement of position at this time. Staff respectfully requests that Arizona Traders Company be ordered to file a response to Order No. 5. Staff further requests that Staff’s deadline to file its supplemental statement of position be extended accordingly.

**III. CONCLUSION**

For the reasons stated above, Staff respectfully requests an order consistent with the foregoing.
