### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

#### T. **INTRODUCTION**

On July 14, 2022, Undine Texas, LLC (Undine) and Nitsch and Son Utility Company, Inc. (Nitsch and Son) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County.

On July 24, 2023, the administrative law judge filed Order No. 13, directing Staff (Staff) of the Public Utility Commission of Texas (Commission) to request a hearing or file a recommendation on the approval of the sale by August 9, 2023.

#### П. **REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. It is Staff's understanding that Undine will soon be providing an update to the details of its sale transaction with Nitsch and Son. Accordingly, Staff respectfully requests that its deadline to request a hearing or file a recommendation on approval of the sale be moved to August 23, 2023, so Staff has time to evaluate the update before it submits its recommendation. Staff has conferred with counsel for Undine and is authorized to represent it is unopposed to the extension request.

#### ΠI. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to August 23, 2023, to request a hearing or file a recommendation on the approval of sale.
