COMMISSION STAFF'S UNOPPOSED REQUEST FOR EXTENSION

On July 14, 2022, Undine Texas, LLC and Nitsch and Son Utility Company, Inc. (collectively, the "Applicants") filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Rockwall County. Specifically, the Applicants seek approval to acquire facilities and to transfer water service area held under Certificate of Convenience and Necessity (CCN) No. 13260.

On August 1, 2024, the administrative law judge (ALJ) filed Order No. 26, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of Undine Texas' filing by September 17, 2024. Therefore, this pleading is timely filed.

I. UNOPPOSED REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff is coordinating with the Applicants to prepare final documents and revise language in the joint proposed notice of approval. Therefore, Staff respectfully requests an extension of time until September 24, 2024, for both the parties and Staff to file their recommendations as per Order No. 26. Staff has conferenced with the Applicants and can represent the request is unopposed.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to September 24, 2024, to file their recommendations as per Order No. 26.
