COMMISSION STAFF’S REQUEST FOR EXTENSION

On July 14, 2022, Undine Texas Environmental, LLC (Undine) and Nitsch and Son Utility Company, Inc. (Nitsch & Son) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County, Texas.

On October 14, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline for the Staff (Staff) of the Public Utility Commission of Texas (Commission) a supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule, if appropriate, by November 8, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Due to an outstanding issue Staff is working with Undine to address, Staff needs additional time to submit its recommendation. Therefore, Staff respectfully requests that the deadline be extended to November 21, 2022.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to November 21, 2022, to file its supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule.
