**APPLICANT'S STATUS REPORT**

On July 14, 2022, Nitsch and Son Utility Company, Inc. (Nitsch) and Undine Texas Environmental, LLC (Undine) (together, the Applicants) filed an application with the Public Utility Commission of Texas (Commission) for sale, transfer, or merger of facilities and certificate rights in Harris County. Supplemental information was filed on July 25, September 15 and 22, October 6, November 9 and 10, 2022; and June 19 and September 27, 2023.

On July 12, 2023, the administrative law judge (ALJ) filed Order No. 16 approving the transaction and requiring Applicants to file monthly updates regarding the status of the closing.

**I. STATUS UPDATE**

This application was filed concurrently with the application by Nitsch and Undine Texas, LLC, for sale, transfer or merger of facilities and certificate rights (the Water Application), under PUC Docket No. 53827. Applicants intend to complete both transactions at the same time. Because the Water Application remains pending, the closing of this transaction remains pending. The applicant reports there have not been any material changes in its financial, managerial, and technical capability to provide continuous and adequate service to the requested area and the Applicant's service area.
