# COMMISSION STAFF'S REQUEST FOR EXTENSION

On July 25,2022, Undine Texas Environmental, LLC (Undine) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20816 in Fort Bend County under Texas Water Code §§ 13.242 through 13.250 and 16 Texas Administrative Code §§ 24.225 through 24.237.

On August 30, 2022, the administrative law judge (ALJ) filed Order No. 2, establishing a deadline for the Staff (Staff) of the Public Utility Commission of Texas (Commission) a supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule if appropriate, by October 26, 2022. Therefore, this pleading is timely filed.

# I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to draft its supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule due to the subject matter expert's conflict with a previously scheduled conference. Therefore, Staff respectfully requests that the deadline be extended to November 4, 2022.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to November 4, 2022, to file its supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule.
