COMMISSION STAFF’S REQUEST FOR EXTENSION

I. INTRODUCTION

On July 25, 2022, Undine Texas Environmental, LLC (Undine) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20816 in Fort Bend County under Texas Water Code §§ 13.242 through 13.250 and 16 Texas Administrative Code §§ 24.225 through 24.237.

On December 1, 2022, the administrative law judge (ALJ) filed Order No. 5, establishing a deadline for the Staff (Staff) of the Public Utility Commission of Texas (Commission) a recommendation on the sufficiency of notice by January 13, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. After reviewing Undine’s notice, Staff noticed an issue with Undine’s notice that Undine has agreed to correct. Accordingly, Staff requests that its deadline to file a recommendation on the sufficiency of notice be extended to February 13, 2023, to give Undine sufficient time to address Staff’s concern. Staff has conferred with counsel for Undine about the proposed extension and is authorized to represent Undine is unopposed.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff’s deadline to February 13, 2023, to file its recommendation on the sufficiency of notice.
