COMES NOW, Staff (Staff) of the Public Utility Commission of Texas (Commission) and Applicant, Undine Texas Environmental, LLC (Undine), and files this their Joint Motion to Abate and would show the ALJ as follows:

I. BACKGROUND

On July 25, 2022, Undine Texas Environmental, LLC (Undine) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20816 in Fort Bend County under Texas Water Code §§ 13.242 through 13.250 and 16 Texas Administrative Code §§ 24.225 through 24.237.

II. MOTION TO ABATE

Counsel for Undine and Staff conferred and conclude an abatement would be appropriate in this docket inasmuch as the discharge permit is in the early stages wherein the Application was submitted on July 25, 2022 and the NORI notice was completed on November 16, 2022 (Docket Id. 53869-24) which is now in technical review for development of the draft permit.

III. CONCLUSION

As detailed above, Staff and Undine respectfully requests an order abating this proceeding until October 13, 2023.
