JOINT STATUS REPORT

On July 25, 2022, Undine Texas Environmental, LLC (Undine) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20816 in Fort Bend County, Texas under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Undine filed supplemental information on July 26, September 15 and 22, October 6, and November 9 and 10, 2022.

On April 17, 2023, the administrative law judge (ALJ) filed Order No. 9 abating the proceeding and requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Undine to file a joint status report by October 13, 2023. Therefore, this pleading is timely filed.

JOINT STATUS UPDATE

The discharge permit application associated with this docket was submitted to the Texas Commission on Environmental Quality in July 2022 and is still pending before that agency. The agency issued a notice of preliminary decision on the application on May 3, 2023, and the comment period on the application closed on July 18, 2023, with no hearing requests. Accordingly, we anticipate permit issuance in the next 30 to 60 days. Because the application remains pending, continued abatement in this matter remains appropriate.
