APPLICANT'S RESPONSE TO ORDER NO. 11

I. Background

On January 14, 2024, the Administrative Law Judge (ALJ) issued Order No. 11 lifting abatement, requiring clarification, and adopting a procedural schedule.

II. Response

Applicant Undine Texas Environmental, LLC (Undine) provides the clarifications below in response to request for clarification or supplemental information.

- A. By February 5, 2024, Undine must identify the documents that have been filed in this docket which constitute its capital improvement plan.
 - Please see the attached **Exhibit A** (submitted confidentially), containing a copy of Undine's Capital Improvement Plan.
- B. By February 5,2024, Undine must identify the location in the record of its loan approval documents or firm capital commitment.
 - Please see the attached **Exhibit B** (submitted confidentially), containing a copy of correspondence from Texas Capital Bank, dated September 7, 2023.
- C. By February 5,2024, Undine must file an affidavit confirming that notice was mailed by first-class mail to each owner of a tract of land that is at least 25 acres and is wholly or partially included in the requested area according to the most

current tax appraisal rolls of the applicable central appraisal district at the time the

Commission received the application for the CCN amendment.

Undine notifies the ALJ that, pursuant to the affidavit of Carey A. Thomas, attached hereto

as Exhibit C, there are no owners of a tract of land that is at least 25 acres and is wholly

or partially included in the area proposed to be certified.

III. Conclusion

Undine requests that the ALJ consider this information in clarification of the

information previously submitted in the docket.
