At the October 6, 2022, Open Meeting, the Commission endorsed Commission Staff's recommendation to develop a streamlined registration form for Aggregated Distributed Energy Resources (ADERs) to register with the Commission. Attached is the ADER Registration Form for the Commission's review and adoption. This form has been reviewed by the ADER Task Force.

- 1) open a new control number for market participants to file completed forms;
