### COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

## I. INTRODUCTION

On August 1, 2022, Monarch Utilities I L.P. (Monarch) and the Creek Water Utility, LLC (Creek Water) (collectively Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Marion County, Texas, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. On November 28, 2022, the administrative law judge (ALJ) issued Order No. 6, recognizing that Monarch has changed its name to Texas Water Utilities, L.P. (Texas Water) on November 15, 2022 and restyling the application accordingly.

On November 3, 2022, the administrative law judge filed Order No. 5, establishing a deadline of December 27, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice.<sup>1</sup> Therefore, this pleading is timely filed.

#### II. RECOMMENDATION ON NOTICE

Staff has reviewed the proof of notice provided by Texas Water and recommends that notice is sufficient. Specifically, Texas Water provided an affidavit of notice dated November 21, 2022, and signed by George Freitag, Texas Water's Texas Regulatory Manager, that notice was provided on November 18, 2022, to its current customers, neighboring utilities, and affected parties, as well as the maps that were attached to the provided notice. Therefore, Staff recommends

that the notice provided by Texas Water be deemed sufficient for the further processing of this matter.
