**COMMISSION STAFF’S SUPPLEMENTAL MOTION TO ADMIT EVIDENCE**

**I. INTRODUCTION**

On August 1, 2022, Monarch Utilities I L.P. (Monarch) and the Creek Water Utility, LLC filed an application for sale, transfer, or merger of facilities and certificate rights in Marion County, Texas, under Texas Water Code § 13.301 and 16 Texas Administrative Code § 24.239. On November 28, 2022, the administrative law judge (ALJ) issued Order No. 6, recognizing that Monarch has changed its name to Texas Water Utilities, L.P. on November 15, 2022, and restyling the application accordingly.

On April 12, 2023, the ALJ filed Order No. 18, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental motion to admit its April 10, 2023, clarification, if it chooses to have the response included as part of the record in this case, by April 19, 2023. Therefore, this pleading is timely filed.

**II. SUPPLEMENTAL MOTION TO ADMIT EVIDENCE**

Staff respectfully requests that Commission Staff’s April 10, 2023 clarification be admitted into the record.
