TEXAS WATER UTILITIES, L.P.'S REQUEST FOR EXTENSION OF TIME

Texas Water Utilities, L.P. (TWU) files this request for extension of time to file the closing documentation and customer deposit information required by 16 Texas Administrative Code (TAC) § 24.239(k) and (/). In support, TWU would show the following:

I. BACKGROUND

On August 1, 2022, TWU and Creek Water Utility, LLC (collectively, applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Marion County, Texas. On March 15, 2023, the administrative law judge (ALJ) issued Order No. 15 Approving Sale and Transfer to Proceed, which established a deadline for applicants to file proof that the transaction has been completed and customer deposits, if any, have been addressed by no later than 30 days after the effective date. The transaction was completed on May 18, 2023. This request is therefore timely filed on or before June 19, 2023.

II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), TWU requests the extension of the deadline to file the closing documents and customer deposit information to June 26, 2023, to give TWU additional time to prepare the customer deposit information. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence.

III. CONCLUSION

TWU respectfully requests the issuance of an order granting its request and extending the deadline for TWU to file the documents and information required by 16 TAC § 24.239(k) and (l) to June 26, 2023.
