3. The deposit held by CWU for each customer, including accrued interest amounts as indicated in confidential Exhibit 1 to this affidavit, has been refunded to the customer.

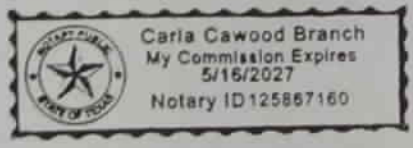
