## TEXAS WATER UTILITIES, L.P.'S REQUEST FOR EXTENSION AND AMENDED PROCEDURAL SCHEDULE

On August 8, 2022, Texas Water Utilities, L.P. (TWU) and Creek Water Utility LLC (collectively, Applicants) filed an application for the transfer of facilities and certificate rights. On July 27, 2023, the administrative law judge (ALJ) issued Order No. 25, setting September 1, 2023, as the deadline for Applicants to file a signed consent form with the Public Utility Commission of Texas (Commission). Therefore, this request is timely filed.

#### I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), TWU respectfully requests the extension of the deadline to file signed consent forms to September 11, 2023, to give TWU and Commission Staff additional time to revise the tariff to include all rates currently approved for TWU. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. Additionally, TWU requests conforming amendments to the procedural schedule established in Order No. 25 as follows:

Deadline for Commission Staff to provide revised final maps, certificates, and tariffs to applicants for review and consent	September 11, 2023
Deadline for applicants to filed signed consent forms with the Commission	September 18, 2023
Deadline for parties to jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs	September 18, 2023

Order No. 25 Finding Notice and Closing Documentation Sufficient, as Supplemented, and Establishing Procedural Schedule (Jul. 27, 2023).

TWU has conferred with Commission Staff who indicated that they are unopposed to the requested extension and modified procedural schedule.

#### II. CONCLUSION

TWU respectfully requests the issuance of an order granting its request and extending the deadline to file signed consent forms to September 11, 2023, and the approval of the proposed conforming modifications to the procedural schedule established in Order No. 25. TWU requests the extension of this deadline for good cause. Finally, TWU requests any other relief to which it may be entitled.
