TEXAS WATER UTILITIES, L.P.'S UNOPPOSED REQUEST FOR EXTENSION OF TIME

Texas Water Utilities, L.P. (TWU) files this unopposed request for extension of time to file the signed consent forms and joint supplemental motion to admit evidence and proposed notice of approval. In support, TWU would show the following:

I. BACKGROUND

On August 1, 2022, TWU and Creek Water Utility, LLC (collectively, Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Marion County, Texas. On September 5, 2023, the administrative law judge (ALJ) issued Order No. 26 Granting Extension and Amending Procedural Schedule, which established a deadline of September 18, 2023, for Applicants to file signed consent forms and for parties to file a joint proposed notice of approval.

II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), TWU requests the extension of the deadline to file the signed consent forms and joint proposed notice of approval to September 25, 2023, to give Applicants additional time to sign the consent form. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. TWU has conferred with the Staff (Staff) of the Public Utility Commission of Texas (Commission) and is authorized to indicate that Commission Staff is unopposed to the requested extension.

III. CONCLUSION

TWU respectfully requests the entry of an order granting its request and extending the deadline for Applicants to file signed consent forms and the parties to file a joint proposed notice of approval to September 25, 2023.
