SECOND JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

Texas Water Utilities, L.P. (TWU)—on behalf of itself, Creek Water Utility, LLC (collectively, Applicants), and the Public Utility Commission of Texas (Commission) Staff (collectively, the Parties)—files this Second Joint Supplemental Motion to Admit Evidence. In support thereof, the Parties show the following:

I. BACKGROUND

On September 26, 2023, the Parties filed a Joint Supplemental Motion to Admit Evidence and Proposed Notice of Approval that included the final certificate of convenience and necessity map agreed to by Applicants and Commission Staff. On October 25, 2023, Order No. 29 Requiring Revised Final Map was issued, requiring the Parties to file a revised final map, to reflect the correct docket number for this proceeding, along with a request that that map be admitted into evidence, by November 1, 2023. Therefore, this pleading is timely filed.

II. SECOND SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

The Parties move to admit the following evidence into the record of this proceeding:

- (a) Revised final map, provided as Attachment A to this pleading.


III. CONCLUSION

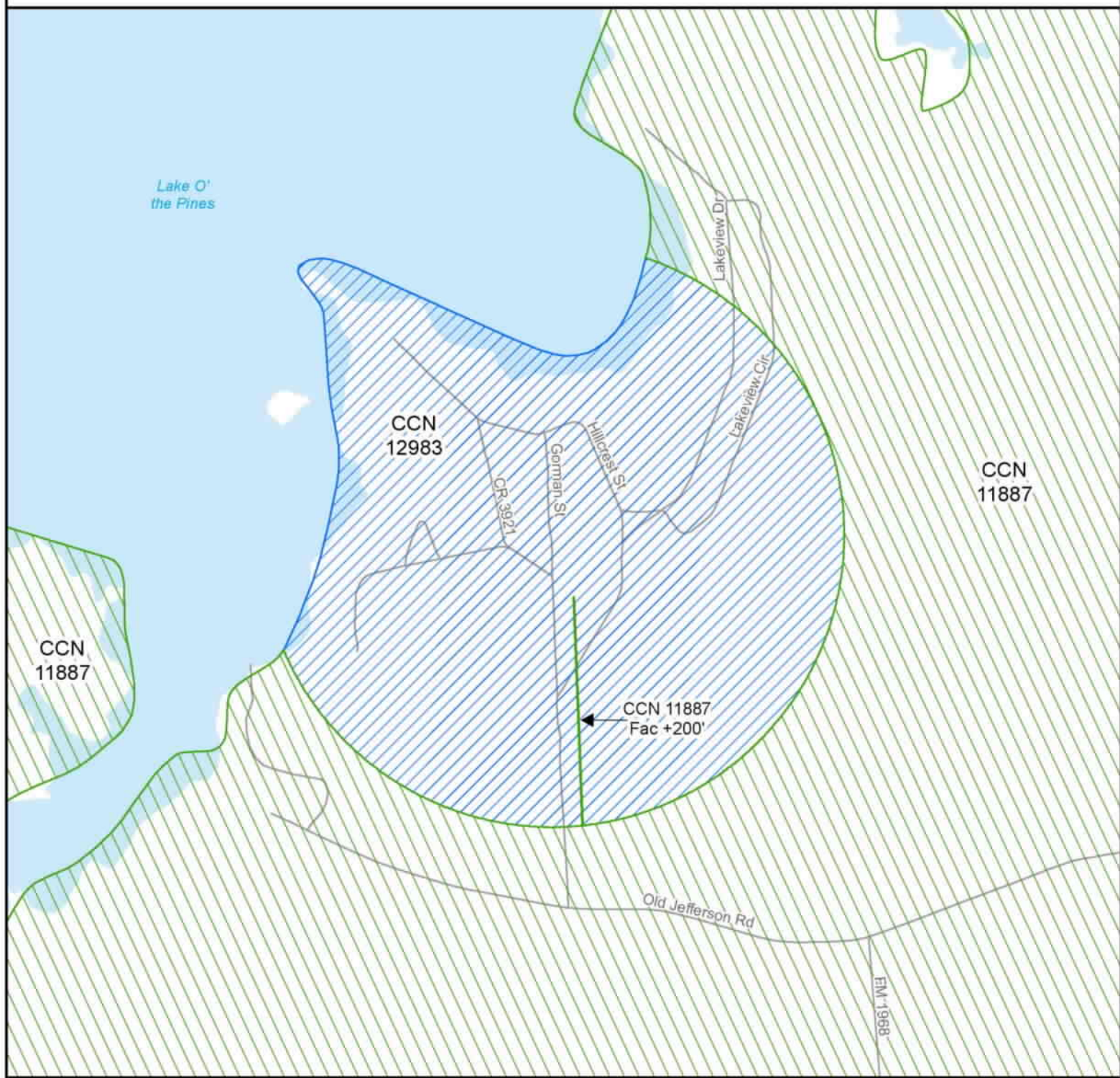
