COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS, PROPOSED NOTICE, AND PROPOSED PROCEDURAL SCHEDULE AND REQUEST TO RESTYLE THE DOCKET

On August 1, 2022, Skyline Drive Landowners Association Water System (SDLA) and Johnson County Special Utility District (Johnson County SUD) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Johnson County. Specifically, Johnson County SUD, Certificate of Convenience and Necessity (CCN) No. 10081, seeks approval to acquire facilities and to transfer all of the water service area from SDLA under water CCN No. 12479. On December 19, 2022, the Applicants filed an amended application, in which Johnson County SUD also seeks approval to amend its CCN for uncertificated service area separate from the area to be transferred in the STM.

On December 1, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of January 23, 2023 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the administrative completeness of the application and proposed notice and propose a procedural schedule. Therefore, this pleading is timely filed.

I. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the amended application and, as detailed in the attached memoranda from Jolie Mathis, Infrastructure Division and Fred Bednarski, Rate Regulation Division, recommends that the amended application is administratively complete. Staff's recommendation on administrative completeness is not a comment on the merits of the application.

II. PROPOSED NOTICE

At this time, Staff recommends that the Applicants proceed with providing public notice to all current customers, neighboring utilities, political subdivisions, landowners, and other persons

listed in Ms. Mathis' memorandum using the notice forms provided. Along with each individual notice, Staff recommends that the Applicants provide an accurate map delineating the requested service area. Staff further recommends that the Applicants publish notice of the application for two consecutive weeks in a newspaper of general circulation in Johnson County.

Once notice has been provided, Staff recommends that the Applicants file proof of individual and published notice, as described in Ms. Mathis' memorandum. Specifically, for proof of individual notice, the Applicants must file an affidavit specifying the name and address of every person and entity to whom notice was provided, the date that the notice was provided, and a copy of the notice and attached map that was provided. And for proof of published notice, the Applicants must file a completed publisher's affidavit and a copy of the newspaper tear sheets demonstrating publication. Finally, Staff recommends that the Applicants use the attached notice forms and affidavits to meet these requirements.

III. PROPOSED PROCEDURAL SCHEDULE

Staff recommends that the application be found administratively complete. Therefore, Staff proposes the following procedural schedule:

IV. REQUEST TO RESTYLE THE DOCKET

Staff respectfully recommends that the docket be restyled as Application of Skyline Drive Landowners Association Water System and Johnson County Special Utility District for Sale, Transfer, or Merger of Facilities and to Amend Johnson County Special Utility District's Water Certificate of Convenience and Necessity in Johnson County. Specifically, based on the amended application, in addition to seeking to acquire SDLA's facilities and certificated service area,

Johnson County SUD also seeks to amend its CCN to add uncertificated service area. Further, SDLA's certificated name is *Skyline Drive Landowners Association Water System*.¹

V. CONCLUSION

For the reasons detailed above, Staff recommends that the application be found administratively complete, that the Applicants be directed to provide notice as detailed above and in Ms. Mathis' memorandum, that the docket be restyled as proposed above, and that the proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.

On August 1, 2022, Johnson County Special Utility District (Johnson County SUD) and Skyline Drive Landowners Association Water System (SDLA) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Johnson County, Texas, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. On December 19, 2022, the Applicants filed an amended application, in which Johnson County SUD also seeks approval to amend its CCN for uncertificated service area separate from the area to be transferred in the STM.

Specifically, Johnson County SUD, Certificate of Convenience and Necessity (CCN) No. 10081, seeks approval to acquire facilities and to transfer all of the water service area from SDLA under water CCN No. 12479. Additionally, as detailed above, Johnson County SUD also seeks approval to amend its CCN to add uncertificated service area.

Based on the mapping review by Hank Journeay, Infrastructure Division, the revised maps submitted with Item 8 and revised digital mapping data submitted with Item 9 on December 19, 2022 are sufficient.

- The requested area includes 34 customer connections and approximately 88.5 acres, comprised of:
 - 26.8 acres of uncertificated area; and
 - 61.7 acres of transferred area from CCN No. 12479.
- The application proposes the subtraction of approximately 61.7 acres from CCN No. 12479 and the addition of approximately 88.5 acres to CCN No. 10081.

Based on the mapping review and my technical and managerial review of the additional information filed on December 19, 2022, I recommend that the application be deemed administratively complete. I further recommend that the Applicants be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - Brazos River Authority
 - James A Dyche (CCN No. 12037)
 - Texas Water Utilities LP (CCN No. 12983)
 - b. The county judge of each county that is wholly or partially included in the requested area:
 - Johnson County Judge.
 - c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - Prairielands Groundwater Conservation District
 - d. Each owner of a tract of land that is at least 25 acres and is wholly or partly located in the requested area. Notice must be mailed to the owner of the tract of land according to the most current tax appraisal rolls of the applicable central appraisal district at the time the application was filed.
 - e. Any affected customers, and other affected parties in the requested area.

Addresses can be obtained from the Water Utility Database at http://www.puc.texas.gov/watersearch. District information and addresses can be obtained from the Texas Commission on Environmental Quality's (TCEQ) web site located at https://www14.tceq.texas.gov/iwud/index.cfm.

- 2) Publish notice once each week for two consecutive weeks in a newspaper having general circulation in the county where the requested area is located. Proof in the form of a publisher's affidavit must be filed within 30 days of the publication date. The affidavit must state with specificity each county in which the newspaper is of general circulation. Within 30 days of the date the notice was mailed, Johnson County SUD must file an affidavit specifying the notice that was provided to every person and entity to whom notice was provided and the date the notice was mailed.
- 3) Provide notice using the attached notice forms.
- 4) Provide a copy of the maps deemed sufficient during administrative review delineating the requested area with each individual notice to neighboring utilities, other affected parties, landowners and customers.

5) File in the docket copy of notice and the maps deemed sufficient during administrative review along with the signed affidavit specifying every person and entity to whom notice was provided, specify whether or not landowners were provided notice the date that the notice was provided, and the publisher's affidavit and tear sheets for proof of newspaper publication.
