JOINT REQUEST FOR ABATEMENT

On August 1, 2022, Skyline Drive Landowners Association (SDLA) and Johnson County Special Utility District (Johnson County SUD) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Johnson County. Specifically, Johnson County SUD, Certificate of Convenience and Necessity (CCN) No. 10081, seeks approval to acquire facilities and to transfer all of the water service area from Skyline Drive under water CCN No. 12479.

On August 2, 2022, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of September 1, 2022 for the (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the administrative completeness of the application and proposed notice and propose a procedural schedule. Therefore, this pleading is timely filed.

I. REQUEST FOR ABATEMENT

Applicants and Staff (collectively, Parties) request an abatement of this proceeding. Specifically, SDLA filed an application to decertify a portion of it water CCN under Docket No. 52453. On July 19, 2022, the ALJ in Docket No. 52453 filed a proposed order and memorandum, requesting the docket be placed on an open meeting agenda for the Commissioner's consideration. If SDLA's application is approved, the final order would decertify approximately 22 acres from SDLA's water CCN that was incorrectly included in SDLA's initial certificated service area.³
