Subject: Docket 53922-Notice of Approval-County Filing

On July 9, 2024, the Public Utility Commission of Texas (PUC) filed the Notice of Approval of the sale, transfer, or merger of facilities and certificate rights between Skyline Drive Landowners Association (LOA) (12479) Water System and Johnson County Special Utility District (JCSUD) (10081).

Per Section III. Ordering Paragraphs (7), JCSUD must comply with the recording requirements in TWC 13.257(r) and (s) for the area in Johnson County affected by the application and must submit to the Commission evidence of the recording no later than 45 days after the date of the Notice of Approval.

Attached to this memorandum, JCSUD is providing a copy of the Notice, filed with the Johnson County Clerk's office as Instrument Number 2024-19902, that satisfies the recording requirements in TWC 13.257(r) and (s).

# Johnson County Special Utility District Water Service Area CCN No. 10081; PUC Docket No. 53922

Pursuant to Texas Water Code § 13.257, Johnson County Special Utility District (JCSUD), holder of Certificate of Convenience and Necessity (CCN) No. 10081, herby files the boundary description for (1) the sale and transfer of all facilities and water service area held by Skyline Drive under CCN number 12479 to JCSUD; (2) the amendment of JCSUD CCN number 10081 to include all facilities and service area previously held by Skyline Drive under CCN number 12479; (3) the cancelation of Skyline Drive's CCN number 12479; and (4) the amendment of JCSUD's CCN Number 10081 to add 26.8 acres of uncertificated area, to the extent provided in the notice of approval by the Public Utility Commission (PUC) on July 9, 2024, in Docket No. 53922. The CCN sale, transfer, and amendments are further described in Exhibit A, the CCN area descriptions, and further depicted in the PUC-certified CCN map attached as Exhibit B.

Based upon information and belief, the boundary description is being filed on behalf of and at the request and instruction of JCSUD. JCSUD explicitly authorizes filing this boundary description to comply with Texas Water Code § 13.257 and its associated rules and regulations.


