**EXCEPTIONS AND CORRECTIONS TO THE PROPOSED ORDER**

**TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:**

COMES NOW, Morgan Acres, LLC ("Petitioner" or "Morgan Acres") and files these Exceptions and Corrections to the Proposed Order issued by the Honorable Administrative Law Judge ("ALJ") on January 23, 2023, proposing that the Public Utility Commission of Texas (the "Commission") release the tract of land identified in the petition from Johnson County Special Utility District's ("JCSUD") service area under certificate of convenience and necessity (CCN) number 10081.
